**Minutes for the Meeting
of the Governing Body
Tuesday June 3, 2014**

The meeting was called to order by Mayor Robert Sims at 7:00 p.m.

A motion was made by Councilman Ming to approve the minutes for the regular scheduled meeting of May 20, 2014 as written. Motion was second by Councilman Hulsopple. Carried 5 - 0

Old Business: Council approved city attorney Todd Luckman's and Maintenance Supervisor Scott Lester's letters to Jim Jones regarding the sewer connection at 302 S Topeka Ave.

New Business: Councilman Hulsopple made a motion to allow Chuck Troutman to conduct a Flea Market at the City Park on September 5th and 6th. Motion was second by Councilman Burkdoll. Carried 5 – 0

Gutter projects tabled until June 17th meeting to allow time for additional bid from Chris Kendall.

Councilman Hulsopple made a motion to approve the purchase of 4 Mud King Tires costing \$676.86 for the fire department's brush truck. Motion was second by Councilman Jackson. Carried 4 – 1 (G Burkdoll)

Councilman Ming made a motion to approve placing Joey Waller on the fire department for the ninety day probationary period effective June 1, 2014. Motion second by Councilman Hulsopple. Motion amended to a start date of June 3, 2014 by Ming and second by Hulsopple. Carried 5 – 0

Councilman Hulsopple made a motion to approve \$434.95 to purchase four tires from Carl's Tire and Auto and align the 2011 Impala at Santa Fe Collision. Motion was second by Councilman Jackson. Carried 4 – 1 (G Burkdoll)

Councilman Jackson made a motion to allow Kyle Almont to do a ride-a-long with the police department one day this week. Motion was second by Councilman Ming. Carried 5 – 0

Councilman Burkdoll made a motion at 7:31 p.m. to go in to a ten-minute executive session with Larry Alexander for non-elected personnel issue. Motion second by Councilwoman Burkdoll. Carried 5 – 0. Council returned to regular session at 7:41 p.m.

Councilman Burkdoll made a motion at 7:43 p.m. to go in to a fifteen-minute executive session for non-elected issues with the right to call in Larry Alexander or Bobi Morris if needed. Motion was second by Councilwoman Burkdoll. Carried 5 – 0. Council returned to regular session at 7:59 p.m.

Councilman Burkdoll made a motion at 8:00 p.m. to go back in executive session for non-elected personnel issue with the right to call in Larry Alexander or Bobi Morris if needed. Motion was second by Councilman Ming. Carried 5 – 0. Council returned to regular session at 8:16 p.m.

Councilman Burkdoll made a motion to approve a six month leave of absence for part-time officer Monty Amick and hire Kenen Martinez as a part-time temporary officer at \$10.00 an hour. Motion was second by Councilman Ming. Carried 5 – 0

Councilman Burkdoll made a motion to have the city clerk send a notice to Veronica Delaney stating she had thirty days to get the construction phase of her new residence started or the temporary electric service will be stopped. Motion was second by Councilman Jackson. Carried 5 – 0

Councilman Burkdoll made a motion to approve ordinances 21 & 22 allowing payment of the city debts and payroll. Motion was second by Councilman Jackson. Carried 5 – 0

Councilman Hulsopple made a motion to adjourn the regular scheduled meeting at 8:50 p.m. Motion was second by Councilman Jackson. Carried 5 – 0
