New Business: Councilwoman Miner made a motion at 7:02 p.m. to go in to a five-minute executive session to discuss maintenance department issue. Motion was second by Councilman Burkdoll. Carried 4 – 0. Council returned to regular session at 7:07 pm.

Councilman Burkdoll made a motion at 7:10 p.m. to go in to a sixty-minute executive session to conduct job interviews for the maintenance department, and allow Councilman Nedeau to join the session upon his arrival to the meeting. Motion second by Councilwoman Miner. Carried 4 – 0. Council returned to regular session at 8:10 p.m.

Motion was second by Councilman Ming. Carried 5 – 0

Councilman Burkdoll made a motion to hire Dustin Warner as the permanent full-time Maintenance Laborer II at \$10.00 an hour contingent upon Mr. Warner's acceptance. Motion was second by Councilwoman Miner. Carried 5 – 0

Councilman Burkdoll made a motion to adjourn the special call meeting at 9:51 p.m. Motion was second by Councilwoman Burkdoll. Carried 5 – 0
