**Minutes for the Meeting**  
**of the Governing Body**  
**Tuesday July 6, 2010**

The meeting was called to order by Mayor David Barnes at 6:00 p.m.

In attendance were Councilmen; Larry Hulsopple, Jack Mayfield, Gary DeShazer, Randy Jackson and Eddie Lester. Employees; Bobi Morris, Christi Miles, Scott Lester and L.A. Alexander. Citizens; Ken Croucher, Tom Carnes, Betsy Crispin, and Lavonna Lafferty.

A motion was made by Councilman Lester to approve the minutes for the regular scheduled meeting on June 15, 2010 as written. Motion was second by Councilman Mayfield. Motion carried 5 – 0

**Old Business;** Ordinance 615 was tabled until the city attorney could be present.

Mayor Barnes recognized Robert Laubach. Mr. Laubach was not present.

Lavonna Lafferty addressed the council about trucks blocking the alley while unloading at the RC Saloon. Chief L.A. will look in to it.

Councilman Mayfield made a motion at 6:10 p.m. to go in to a ten-minute executive session with Chief Alexander and Chief Croucher present to discuss non-elected personnel issue. Motion was second by Councilman Hulsopple. Carried 5 – 0 Council returned to regular session at 6:20 p.m.

Councilman Mayfield made a motion to approve \$171.00 for parts to tune up the brush truck. Motion was second by Councilman Jackson. Carried 4 – 1 (Lester)

Chief Alexander gave the police report. Councilman Mayfield made a motion to approve \$850.00 for Liggett to remove the equipment for the Crown Vic and install it in the new Impala. Motion was second by Councilman Hulsopple. Carried 5 – 0

Councilman Hulsopple made a motion at 6:32 p.m. to go in to a five-minute executive session with Chief Alexander to discuss non-elected personnel issue. Motion was second by Councilman Mayfield. Carried 5 – 0 Council returned to regular session at 6:38 p.m. Councilman DeShazer made a motion at 6:38 p.m. to extend the executive session five-minutes. Motion was second by Councilman Mayfield. Carried 5 – 0 Council returned to regular session at 6:43 p.m.

Councilman Mayfield made a motion to allow Chief Alexander to enter in to negotiations with Branine Motors for a new Impala, with and without a trade-in. Motion was second by Councilman Lester. Carried 5 – 0

Councilman Hulsopple made a motion to approve the purchase of six (6) hats for the police officers at a cost of \$75.00 each. Motion was second by Councilman Mayfield. Carried 5 – 0

Scott Lester gave the council bids for a new pick-up truck. Council asked Scott to get a few more bids by the next regularly scheduled meeting.

Councilman Hulsopple made a motion to approve ordinances 25 & 26 allowing payment of the city debts and payroll. Motion was second by Councilman Mayfield. Carried 5 – 0

Councilman Hulsopple made a motion to adjourn the regular scheduled meeting at 7:17 p.m. Motion was second by Councilman Jackson. Carried 5 – 0
