Mayor Sims opened the 2014 Budget Hearing.

Old Business; Councilman Burkdoll made a motion to approve the contract with Governmental Assistance Services and authorize Mayor Sims to sign the contract. Motion was second by Councilman Ming. Carried 5 - 0

New Business; Councilman Burkdoll made a motion to approve \$450.00 to send Brent Cox to the FBI training in Lawrence. Motion was second by Councilman Jackson. Carried 4 – 1 (Ming)

Councilman Burkdoll made a motion to approve ordinances 27 & 28 allowing payment of the city debts and payroll. Motion was second by Councilwoman Burkdoll. Carried 5 – 0

Councilman Jackson made a motion to adjourn the regular scheduled meeting at 7:53 p.m. Motion was second by Councilman Hulsopple. Carried 5 – 0
