**Minutes for the Meeting**  
**of the Governing Body**  
**Tuesday September 4, 2012**

The meeting was called to order by Mayor Barnes at 6:00 p.m.

In attendance were Councilmen; Randy Jackson, Robert Sims, Randy Ming & Larry Hulsopple. Councilman DeShazer was absent. Employees; Bobi Morris, Larry Alexander & Brent Cox. Citizens; Tom Carnes, Betsy Crispin, Jennifer Hanni and Rodger Franks.

A motion was made by Councilman Hulsopple to approve the minutes for the 2013 Budget Hearing of August 7, 2012 as written. Motion was second by Councilman Ming. Carried 3 – 0 – 1 (Sims abstain)

A motion was made by Councilman Ming to approve the minutes for the regular scheduled meeting of August 7, 2012 as amended. Motion was second by Councilman Hulsopple. Carried 3 – 0 – 1 (Sims abstain)

**Old Business:** Cindy Jensen of Aldrich & Company CPA's gave the audit report for the year ending December 31, 2011.

Councilman Hulsopple made a motion to accept the 2011 audit report as presented. Motion was second by Councilman Ming. Carried 4 – 0

Rodger Franks addressed the council about their recent decision to approve a variance for David & Jo Babler. Franks wants notification when the Zoning Committee meets.

**New Business:** Mayor Barnes recognized school Principal Jennifer Hanni. She requested and additional crosswalk at the corner of S Burlingame and Bracken. Larry Alexander will check with the city attorney to see if an ordinance is required for the additional crosswalk.

Councilman Hulsopple made a motion to approve the purchase of paint for two crosswalks and three related signs. Motion was second by Councilman Ming. Carried 4 – 0

Councilman Jackson made a motion to elect Gary DeShazer as the city's delegate and Robert Sims as the alternate for the League of Kansas Municipalities. Motion was second by Councilman Hulsopple. Carried 3 – 0 – 1 (Sims abstain)

Councilman Sims made a motion to at 6:46 p.m. to go in to a five-minute executive session to discuss non-elected personnel issue. Motion was second by Councilman Jackson. Carried 4 – 0  
Council returned to regular session at 6:51 p.m.

Councilman Jackson made a motion at 6:52 p.m. to go in to a ten-minute executive session to discuss non-elected personnel issue. Motion second by Councilman Sims. Carried 4 – 0

Councilman DeShazer joined the executive session at 7:00 p.m.

Council returned to regular session at 7:02 p.m.

Mayor Barnes acknowledged that Christi Miles resigned. The clerk had prior commitments and could not be in the office on Miles last day so Miles was given the day off with pay.

Councilman Hulsopple made a motion to approve ordinances 31 & 32 allowing payment of the city debts and payroll. Motion was second by Councilman Ming. Carried 3 – 0

Councilman Hulsopple made a motion to adjourn the regular scheduled meeting at 7:05 p.m. Motion was second by Councilman Ming. Carried 3 – 0
